Going through my Riverlovers Folder, I came across a *Currents* interview of Gunnar and me, written by Jan Ravase in July of 1996. It was charming and of course I found it extremely interesting. I realized we had not done interviews since Jan started the idea way back then. I called Jan and asked if she would like to begin an interview series anew and she agreed. I decided to begin the interview series by interviewing Jan, herself. Jan Ravase has been a Riverlover since as long as I can remember and things just don't feel quite the same when she is not around. Jan grew up and attended private schools in Peekskill. She was born on February 22 during one of the biggest recorded blizzards of the 20th century. No wonder she has so much energy and verve.

Putting her education at Merrimack College, where she majored in History and Secondary Education, to good use, Jan began teaching school in Pittsfield, Massachusetts. After her father died, Jan returned to teach in Peekskill where she taught the children of some of her own school-mates. One of her students was John Testa, the current mayor of Peekskill. Jan has also taught school in Maine and Yonkers, where she was a director of religious education.

Religion has played an important part in Jan's life. I attended a memorial service for her mother two years ago and it was obvious that Jan and her mother were very involved with the Church of the Assumption in Peekskill. It was a memorable day in which the congregation honored Jan's mother's service to the church. Jan did a superb job creating and directing the service; we Riverlovers who attended were moved to tears.

Jan has many hobbies and interests which reflect her sensitivity and romanticism. She has been compiling a unique postcard collection from all over the world since childhood. Her post cards mean a lot to her and she feels a deep sense of communication with the people who send them to her. Jan loves travel, particularly to cities in the U.S.A. where she visits major art museums and gathers postcards of works of art. I was lucky to view her favorite cards of 19th century French art. Now that's romanticism! She recently returned from trips to San Francisco and Niagara Falls with stops at wineries along the way. Where would a real romantic travel to again and again? Bermuda, of course; a place that Jan visits at least every two years.

Jan has a love of nature as well as art. Plants, flowers and animals have always been an important part of her life. A neighborhood cat named Pitch is cared for communally by the members of Jan's housing development. Jan became his favorite when he literally walked into her life five years ago. Jan loves Pitch so much she was willing to give up keeping canaries, which she did for many years.

Jan believes in service to the community; both religious and secular. She is active in Our Lady of Loreto in Cold Spring and is an affiliate of Mary Knoll in Ossining. We are very proud that she has chosen to be a member of Riverlovers, and she is an active member helping to carry out our goals of raising awareness of environmental issues in the community. Close Indian Point Update—Part I

Greetings to those who are engaged in the struggle to close Indian Point.

The relicensing of the reactors at IP 2 and 3 must be stopped. Even if you feel that nuclear power may offer some advantages, the reactors at Indian Point are located in the wrong place. The risks are just too great.

The steering committee of the Indian Point Safe Energy Coalition would like to provide you with this overview of the relicensing process. This is part one in a three-part series. The first, this one, deals with actions individuals can take. The second will outline the process of relicensing. The third part deals with what is currently happening to prevent relicensing.

Remember that there are a great many unknowns and a court case or Congressional action could change the dates of many items. You may find it helpful to file this tentative guide away for future reference.

Here is what to do NOW! Pick one action and do it!

Write, not e-mail, a note to Governor Spitzer. Remind him of his campaign promise and tell him why closing Indian Point is important to you. Ask Spitzer to use the power of his office to prevent the relicensing of the reactors at Indian Point. Use a note card and don't make a big deal out of formal terms of address or anything else. Just get something in the mail. This is something you can do with your kids. Here is the address: Governor Eliot Spitzer, Executive Chamber, State Capitol, Albany, New York, 12224. You can fax him at 518-474-1513.

If you prefer, write Attorney General Cuomo. Thank Cuomo for his involvement in Westchester County's court case to expand the criteria for relicensing. Ask him to continue to use the power of his office to prevent the relicensing of the reactors at Indian Point. The address is New York State Office of the Attorney General, The Capitol, Albany, New York, 12224. If you prefer to call, you can reach his office at 518-474-7330.

Talk to your friends and neighbors about Indian Point. Give them the facts they don't see in the media. Share your concerns and listen to their questions. If you need help with answers, call 1-888-I-Shut-It.

If you can do more, arrange a get-together of friends or colleagues focused on Indian Point. Call the IPSEC Speakers Bureau so that you can have someone there to help answer the tough questions. (1-888-474-8848)

Most people cannot spend a lot of time on closing Indian Point, but everybody can do something. Empower yourself and act now!

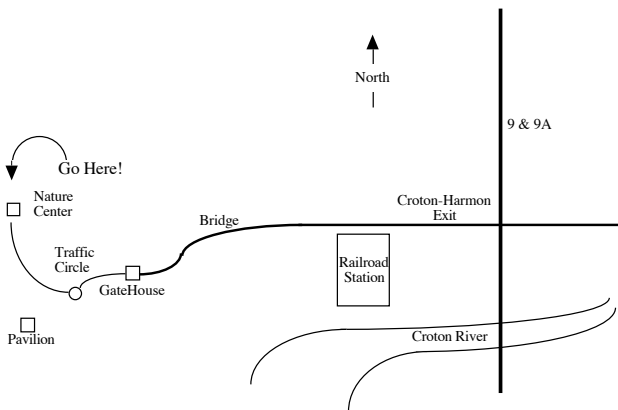
